

REDGRAVE PARISH COUNCIL MEETING - MINUTES 9 July 2014

2. Chairman's Opening: Jason welcomed everyone
3. Declarations of interest - None
4. Minutes of the meeting of Wednesday 11 June 2013 were agreed as a true record
5. Matters arising not covered by this agenda: None
6. Any changes in administration: After a motion proposed by Jackie Moss, seconded by Jan Cresswell, the meeting unanimously approved signature by the Chairman of the offer of employment to Leeann Jackson-Eve as Parish Clerk from 1 September 2014 with a contract of employment to follow later. The positions of Bob Haywood as current clerk and John Giddings as RFO will therefore cease from that date.
7. *Open discussion with county and district councillors, and services*  
*County councillor Jessica Fleming had emailed Councillor Baird advising that she had raised the issue of cutting verges at County level and that all verges on C and U roads should have been cut by 9 July 2014. She requested advice of any omissions and Councillor Baird agreed to do so. District Councillor Sara Michell: confirmed that (1) details of revised refuse collection dates would be mailed directly to residents in conjunction with Serco to avoid the problems last year. (2) She had visited the Great Blakenham incinerator, now in operation and reducing the use of landfill (3) consultation on the development levy is in progress.*

Speed monitoring – (1) 11 letters were issued by the police during the month (2) there are currently 11 volunteers (3) in Suffolk 40% of vehicles reported do not get a letter, in future the police will give fuller reasons for this, the accuracy of reporting is one critical area. (4) The number of drivers reported speeding between January and May is significantly down on the same period in 2013 (5) Councillor Baird had obtained a quote of £2,250 for moveable speed signs.
