## REDGRAVE PARISH COUNCIL MEETING - MINUTES 10 June 2015 Held in the Redgrave Activities Centre at 7.30 pm

- 1. Chairman's Opening: Jason welcomed everyone.
- 2. Apologies: Ann Preston and Neil Smith.
- 3. Declarations of interest: Mike Denmark declared an interest in item 7.1.3 as the owner of the property.
- 4. Minutes of the meeting of 13 May 2015 were agreed as a true record.
- 5. Progress reports not covered by this agenda: None.
- 6. Public Forum: 7.37pm RESOLVED, with all agreed, to adjourn the meeting for the public forum. Derek Osborne gave some up to date information on planning application decisions. Jessica Fleming reported that Colin Noble had been elected Leader of the Council and after a cabinet reshuffle, she would be responsible for "Suffolk the Greenest County". She also reported that any Highways issues could be reported to her, particularly verges. It was agreed that she would approach Highways about the overgrown hedges around the junction of the B1113, Fen Street and Hinderclay Road.

The Chairman reconvened the meeting at 7.48pm.

## 7. Planning:

- 7.1 Applications: None.
  - 7.1.1 Cross Keys, The Street, Redgrave. Ref. 1668/15. Erection of 3 holiday units with associated parking to the rear of Cross Keys Public House. Generally it was felt that the parking arrangements were not up to standard and the size of the site was inadequate for the proposed parking. The proposals did not take into consideration the depth of the boundary hedge and there would not be enough room to accommodate the number of cars shown and allow movement in and out of the spaces. This would result in insufficient parking and increased parking on the street during busy periods, and there would be no scope for safe pedestrian access to the pub and units. It was further commented that the application made no mention of loss of trees, in particular, two large and attractive walnut trees. Finally, it was felt that there were a number of inconsistencies in the application, which did not make a strong argument in favour of additional holiday accommodation in the village. It was the PC's opinion that the need for holiday accommodation was already met and so it was RESOLVED, with all agreed, to object to the application.
  - 7.1.2 Linden Lea, Half Moon Lane, Redgrave. Ref. 1665/15. Erection of front porch. It was RESOLVED, with all agreed, to make no comment.
  - 7.1.2 Pine Tree Cottage, The Street, Redgrave. Ref. 1460/15. Erection of two storey side extension. Re-render property in smooth render. Cllr Denmark had declared an interest as the owner of the property and left the room during the discussion. It was noted that and RESOLVED, with all agreed, to have no objection.
